SAFETY FIRST

Electricity is an integral part of modern life. Given the prevalence of electrical devices, tools and appliances, follow practical electrical safety tips:

- Frayed wires pose a serious safety hazard. Power cords can become damaged or frayed from age, heavy use or excessive current flow through the wiring. If cords become frayed or cut, replace them.
- Avoid overloading circuits. Circuits can only cope with a limited amount of electricity. Overload happens when you draw more electricity than a circuit can safely handle by having too many devices running on one circuit.

 qualified electrician if your home is more than 40 years old and you need to
 install multiple large appliances that consume large amounts of electricity.
- Use extension cords properly. Never plug an extension cord into another
 extension cord, and don't exceed the wattage of the cord. Extension cords
 should not be used as permanent solutions. If you need additional outlets,
 contact a licensed electrician to help.
