ELECTRIC VEHICLE /CHARGING STATION REBATE QUALIFICATIONS

ELIGIBLE MEMBERS

- Residential members in good standing with the cooperative are eligible for rebates when buying qualifying hybrid vehicles and Level 2 or greater charging stations.
- The structure in which the member resides must be a permanent structure on a permanent foundation on the land owned by the member.
- Rebates are limited to eligible homes or businesses that purchase more than 6,000 kilowatt-hours of electricity from the cooperative on an annual basis.

ELIGIBLE PLUG-IN HYBRID VEHICLES

- Member must keep the vehicle for 24 months or upgrade. This is subject to periodic inspection by the cooperative.
- Owner must provide proof of purchase or lease, title application, and bill of sale within 90 days and attach to this form.
- Vehicle must be less than three years old.

ELIGIBLE LEVEL 2 OR FAST CHARGE CHARGING STATIONS

- Equipment must be new and ENERGY STAR rated.
- The cooperative reserves the right to complete an on-site inspection of the charger after install.
- Charging stations that receive rebates **may be subject to cooperative load control programs.** The participant agrees to allow the cooperative to control the timing of their charging equipment now or in the future.
- Member must have meter base installed by qualified electrician. After the base is installed, the cooperative will install an automated meter to take readings from the unit.
- Owner must provide proof of purchase within 90 days and attach to this form.

REBATE DETAILS

- Limit of two rebates per member per year.
- The application must include all the information requested on the front of this application. Incomplete applications will not be processed and will be returned to the member.
- Recipients of rebates may be requested to participate in a future survey by phone or e-mail.
- Please allow 6-8 weeks for rebate processing. Please keep a copy for your records.
- The rebate amount is limited to 50 percent (50%) of the total cost of the unit.
- \$500 Rebate will be in the form of a check and \$250 charger rebate will be in the form of a bill credit.

DISCLAIMER

The cooperative will not rebate equipment that has been mislabeled, misrepresented, or previously owned.
